### Please Read:

The qualifications of Election Officials are generally as follows (Ark. Code Ann. § 7-4-109):

- Must be qualified electors of this state;
- Must be residents of the precincts in which they serve at the time of their appointment unless the county board determines unanimously that it is impossible to obtain qualified election officials from the precincts, in which case they may be qualified county residents;
- Must not have been found guilty or pled guilty or nolo contendere to the violation of any election law of this state;
- Must not be paid employees of any political party;
- Must not be paid employees of any person running for office;
- Must not be a candidate for any office to be filled at an election at which they shall serve;
- Must not be married to or related within the second degree of consanguinity to any candidate running for office in the current election.
