Briefly State How Project Responds to COVID-19 Crisis

During COVID-19, we all were forced to adapt to a new way of operating virtually. This is true of business and healthcare professionals, students, and residents simply asked to remain at home. Without face-to-face interaction, a tremendous burden was placed on all citizens. This was challenging for people who already had access to high quality broadband infrastructure, but it was much more difficult to those who reside in unserved or underserved rural areas, like the proposed funded service area (PFSA) in this application. The lack of access to comprehensive, high-quality, and competitive broadband capacity emphasized and inflated a vast digital divide between the two people groups.

The successful funding of this grant to Conway Corp will ensure that all residents in the PFSA have access to the digital economy through a powerful and future proof fiber to the home network. These residents will be well-positioned for future success no matter if the need is healthcare, education, entertainment, and simply connecting to loved ones. Access to more affordable, reliable, and faster broadband will improve the quality of life for those living and working in the PFSA as all inevitably rely more on their computers and devices as they email, read, complete homework assignments, and communicate with others. Conway Corp continually hears complaints of no access to internet connectivity that allows students to do homework, workers to work from home, or reasonable access to necessary healthcare services.

With grant support, Conway Corp is ready, willing, and able to make a long-term investment to provide qualifying broadband service to the challenging, proposed service area. Conway Corp is a trusted and well-respected service provider in the area and has previously completed fiber buildouts throughout its existing service area. Conway Corp recognizes the economic and community development opportunities associated with better broadband and is committed to meeting the broadband needs of those hardest to serve locations.

County-Wide Impact of Proposed Project

The proposed project is one that is needed to serve an area that is extremely difficult to reach without support. Like many areas across the country, the lack of sufficient and equitable broadband is a direct result from a lack of financial feasibility and sustainability. Without support, this area may continue to be unserved for the foreseeable future. Approval of this project will take a sizeable area and position it

to take advantage of opportunities that stem from broadband infrastructure such as economic development, remote learning capabilities and health care, increased property values, and more.

The goal of ARPA states that the funds will provide substantial flexibility for each government to meet local needs, which includes necessary investments in water, sewer, and broadband infrastructure. This grant application focuses primarily on broadband infrastructure by proposing to install a fiber to the premises project in rural underserved areas on the southwest side of the City of Conway which is within the county outside of the city limits. As mentions previously, the project will install 23 miles of aerial and buried fiber optic cables facilitated by pole attachment agreement or county\state right-of-way, and supply highspeed broadband access to approximately 224 Faulkner residents and businesses, which are easily quantifiable metrics by which to measure progress. Once construction begins, it is estimated to take approximately 258 days to complete. Weather, equipment, and material delays could push the timeframe further. See Appendix A for a map of the PFSA.

The project will upgrade the existing PFSA broadband infrastructure by utilizing Gigabit Passive Optical Network (GPON) technology. GPON is a point-to-multipoint access network, and it uses Asynchronous Transfer Mode (ATM) for voice, Ethernet for data, and proprietary encapsulation for voice. A GPON system consists of an optical line terminal (OLT) that connects several optical network terminals (ONTs/ONUs) together using a passive optical distribution network (ODN). GPON was designed as a "future-proof" solution that supports advances of end user technology without upgrading the entire network infrastructure. This project minimizes operating expenses by limiting the amount of equipment to maintain and replace. GPON is considered a future proof technology, and it technically has limitless potential in terms of data download and upload speeds. See Appendix B for a Network Diagram.


