Brief history of the organization:

Deliver Hope was founded in 2013 to provide Chapel services for at-risk teenagers in the Faulkner County Juvenile Detention Center. We quickly realized that the young people in jail were craving meaningful connections outside the jail walls once released. We began creating programs that would fill that gap, such as youth mentoring for at-risk and parenting teenagers. In 2015, we became an official community partner for the Juvenile Court System in Faulkner County. This allowed us to also begin serving juveniles that were already in the court system. We began facilitating court ordered programs such as restorative justice circles, sober support, mentoring, etc. Currently, we serve over 200 youth each year.
