To whom it may concern,

I am writing this letter in full support of Deliver Hope being a recipient of their requested American Rescue Plan Funds.

As the Juvenile Court Judge, I have attempted to create strong community partners to address juvenile delinquency, truancy and rehabilitative services for our youth. Deliver Hope is one of my strongest partners in this fight.

Since 2016, we have assisted at-risk youth to excel despite their disadvantages by developing and implementing several effective, community-based alternatives to confinement. Programs provided by Deliver Hope ensure court-involved youth have access to healthy alternatives to their homes, restorative programing, transformational mentor relationships, and opportunities to make better choices to prevent future delinquent behavior.

The American Rescue Plan funds will allow Deliver Hope to continue providing safe and effective resources that encourage at-risk youth to move past brokenness and abuse, and work towards changing the trajectory of their lives; and expand their services to focus on rehabilitative, non-punitive diversion options for juvenile offenders so they can resolve conflict and make positive choices.

Since the pandemic, we have seen an increase in more serious delinquent offenses as well as truancy cases. This funding will benefit Faulkner County both immediately and in the future. Your support will help young people recover from the trauma caused by the pandemic, stay out of jail, and become positive and respected community members.

#### 6. Briefly and clearly state how your project responds to the COVID-19 crisis:

During the COVID-19 crisis, teenagers were quarantined inside their homes. Many of these teenagers' homes are filled with drugs, abuse, poverty, and brokenness; and the only positive role models and activities were taken from them. Research shows that during the confinement of 2020, not only did this reduce the safety of these children, it also limited contact of others that may be able to identify those signs of abuse, therefore causing already at-risk teenagers to suffer in silence. https://www.ncbi.nlm.nih.gov/pmc/articles/PMC8689095/

What we have seen in Faulkner County mirrors that of the the above United States findings. Deliver Hope is working diligently to change the narrative that teenagers in Faulkner County have adapted during the pandemic through Youth Mentoring. In order to have the best outcome and reach each teenager, we will hire more Youth Advocates, add hours to existing Youth Advocates, and increase program activities and hours.

# 8. Please describe your project including the following information (in any order): What will this project accomplish? How will those goals be measured? How do these goals relate to the goals of the American Rescue Plan Act (ARPA)?

Deliver Hope will hire two new Youth Advocates, add hours to existing Youth Advocates, and increase program activities and hours. Adding staff will address the issue of not having the availability to perform home visits, serve the needed number of teenagers on caseloads, and facilitate more programs to keep teenagers off the streets.

We will re-implement LAUNCH. LAUNCH is a basketball program that we saw a huge success rate with before COVID-19. This program encourages youth to work together, respect others, and keeps at-risk youth off the streets. Each night will begin with a devotional/character talk/lesson and ends with a friendly competitive basketball game. These funds will be used for food, rental space, jerseys, basketballs, and supplies.

Youth Mentoring is imperative in order to rejuvenate the hurt that teenagers acquired during the pandemic. Not only do we train and partner with adult community members to mentor at-risk teenagers, we also host weekly groups that encourage and foster relationships between them. These group gatherings walk through a curriculum that empowers young people to work towards becoming responsible and respected adult community members, as they are not being taught these skills in their homes. These funds will cover food, games, and supplies for four

quarterly "mentor moment" events as well as weekly mentor trainings and mentoring gatherings for over 200 at-risk teenagers throughout each year.

We will measure the goal of reaching and rejuvenating at-risk teenagers by tracking every interaction made possible with the granted funds. Food, rides, phone calls, meetings, etc. will be recorded in our Social Solutions database. We will implement a pre and post survey with each teenager that enters our building/programs to track their emotional and relational progress throughout their time spent with our organization.

In 2020 we had a staff of six but quickly had to reduce th as our programming had to shift to more phone calls and no in person meetings. At the end of the pandemic we had 2.5 employees. With this funding request we will be able to increase the staff to handle the extra case load.

Our goals relate to the goals of the American Rescue Plan Act, as we are fighting for the physical and mental well being of teenagers in our community. Deliver Hope believes that every young person deserves to know that they matter and are capable of doing great things, no matter what circumstances COVID-19 placed them and their family in. The young people we serve are the future of our community and Deliver Hope is fighting to ensure they grow up to be responsible and successful members of society.

## 10. Are other funds part of the budget besides ARPA funds? If so, please list other courses of funding and a copy of their funding commitment, if available.

We currently have 72 recurring monthly donors totalling \$7,475 and our goal is to increase this to \$10,000 by July 1, 2023, to get us closer to pre-pandemic numbers.

Our fund raising methods previously in-person requests and events all which were immediately dropped during the pandemic. Also due to the inflation we have seen a reduction in our monthly donors.

We are applying for matching APR funds from the Bunny and Carol Adcock Foundation and feel positive about this request due to conversations with Mr. Adcock and his previous gifts to our organization.
