- 2. The sealed bid must include all charges, including taxes, fees, freight charges, hauling, construction debris disposal charges, and any other costs required for execution of the work described herein.

- 3. A performance bond, in the amount of 100 percent of the contract price, with a corporate surety approved by Faulkner County, will be required for the faithful performance of the contract.
- 4. Bidders are encouraged to offer both individual bids and a lump sum bid on the form provided. Faulkner County will choose the lowest responsible bidder that best meets the obligations and requirements of the County, as determined by Faulkner County.
- 5. Faulkner County reserves the right to reject any bid if such bidder fails to satisfy Faulkner County that the bidder is properly qualified to carry out the obligations of the contract and to complete the work contemplated therein.
- 6. Each bidder is responsible for inspecting the site and reading and being thoroughly familiar with the contract documents. The failure or omission of any bidder to do any of the foregoing shall in no way relieve any bidder from ay obligation in respect to their bid.
- 7. In submitting this bid, it is understood by the undersigned bidder that the right is reserved by Faulkner County to reject any and all bids, to waive any informalities, and to accept the bid deemed to be in the best interest of the County.
- 8. All Bidders MUST be registered in SAM.Gov and have an active status at the time of bid opening.

SCOPE OF SERVICES:

- CONTRACTOR must call "One Call" to identify location of utilities and ensure they have been deactivated.
- Demolition Upon issuance of Notice to Proceed, CONTRACTOR shall perform demolition of the residential structure(s), building, slabs, fences, and other items associated with each property.
- Debris Removal/Disposal The demolition debris shall be removed and disposed in accordance with state and local requirements. A copy of disposal receipts from a permitted facility or other documentation must be provided with the CONTRACTOR'S invoice(s) for payment.
- Filling/Grading clean fill material shall be placed on all areas requiring excavation, and the site graded to provide for proper drainage, subject to approval of Faulkner County.
- Seeding/Mulching All disturbed areas within the project site shall be seeded with a winter mix, fertilized, and mulched to provide soil stabilization throughout the winter months.

- Erosion Control Prior to beginning work and disturbing the soil, measures shall be implemented to prevent sediments from leaving the project site and entering adjacent roadways and waterways.
- Work to be completed within 45 days from notice to proceed: additional time may be allowed if there is a delay in Closing Process or Asbestos Abatement.
- Any approval of additional time will be at the sole discretion of Faulkner County.

SAFETY, PERMITS, AND LICENSES:

- An asbestos survey, for those required, will be furnished.
- All work activity must comply with Occupational Safety and Health act (OSHA)
 Standards and any other Federal, State or Local rules and regulations applicable to
 construction, demolition, and/or maintenance activities in the State of Arkansas.
- Any County personnel may, but are not required to, order that work be stopped if a
 condition of immediate danger is found to exist. Nothing contained herein shall be
 construed to shift responsibility or risk or loss for injuries or damage sustained as a result
 of a violation of these safety articles from CONTRACTOR to County. CONTRACTOR
 shall remain solely and exclusively responsible for compliance with all safety
 requirements and for safety of <u>all</u> persons and property on project site.
- Special care shall be taken to protect properties adjacent to the project site. The CONTRACTOR will be responsible for any bodily injury, property damage, and or any other loss that arises from this work.
